DIRECTIONS FOR USE

Application:

EUCO Release WB may be applied by brush or conventional mold oil sprayer. If a mold oil sprayer is used, it is important that a fine nozzle is fitted as Oxirelease WB should be applied in a light continuous film. If EUCO Release WB is over applied, excess material should be allowed to drain and then be carefully removed from the bottom of the mold by means of a sponge or cloth. Pools of Oxirelease WB should not be allowed to dry otherwise surface retardation of the concrete will occur.

Demolding:

After use, the formwork or mold should be brushed or wiped clean of any excess dust prior to re- application of EUCO Release WB for the next use of the mold. The use of EUCO Release WB minimizes the amount of time and effort required for this process.
